Session 2 **Identifying impediments to trade**

Plenary 14:00 Expert panel will discuss the use of time-release survey (TRS) as a tool for identifying impediments to trade.

TRS is designed to measure the time taken from the arrival of goods at the port until their release to an importer or third party and the aim is to determine where in the process problems exist, the types of problems, the reasons for these problems and possible solutions.

Presentations will highlight the ability of TRS to determine the impact of customs administrations, other government agencies and industry on the time taken to release goods to an importer. Australian Customs will discuss its plans to implement TRS.

Breakout 15:30 Government and industry delegates will discuss the potential benefits of TRS and identify relevant implementation issues, particularly for the survey to be conducted in Australia.
