What is required to “Receive” Foreign Currency via ComPay?

For existing ComPay members we require you to complete a Foreign Currency registration form providing your foreign bank account details. Please contact 1-Stop directly to request this form.

If you are not yet a registered member of ComPay you can complete the on-line registration details at www.1-stop.biz and you will be asked to provide details of your foreign bank accounts.

What Fees are applicable to Pay and Receive in Foreign Currency?

For the Payer

- An introductory offer of AUD\$5.00 transaction fee applies for each payable foreign currency transaction
- AUD\$10.00 transaction fee applies for each payable foreign currency transaction (*Effective from 1st July 2009*).

For the Payee

- An introductory offer whereby the Foreign Currency Registration Fee is waived.
- AUD 120.00 one off Registration Fee applies for any new registrations (*Effective from 1st July 2009*).
- AUD 10.00 ongoing Monthly Fee applies to receiving unlimited foreign currency transactions.

Will I receive any training on how to make foreign currency payments?
